# Call for Artists : 2010 Artists in Residency Program (Short-term) at Seoul Art Space\_Geumcheon(SASG)

## 1. General Information

### ○ Genre and numbers of artists

- Domestic : Arts planners, critics, and mediators / 4~5
- International : Visual artists, performing artists, arts planners, and critics / 4~5

### ○ Duration of residency

- Short-term A : 2010.5.1-6.30
- Short-term B : 2010.7.1-8.30

※ It is not available to apply for both session A and B at the same time.  
Select only one period.

### ○ Eligibility

- General eligibility
    - Artists age over 25 (College students are not applicable.)
    - Artists available to participate in programs of SASG and to collaborate with international artists.
  - Specific eligibility
    - Domestic : Planners, critics, directors, and mediators working in Korea
    - International : An artist having his/her citizenship in overseas countries or residing in foreign countries.
- ※ Individual artist ONLY. In case of small group, SASG accepts Max. number of two.
- Ineligibility
    - Associations and Institutes
    - For-profit organizations
    - A group or a team not intending artistic creation operated by schools,

religious organizations, etc.

## ○ Terms

- Using a studio at least fifteen days a month (※ A special cause should be notified and arranged before an artist's participation in the program.)
- Monthly payments for a studio (※Monthly payments of 5,000KRW/3.3m<sup>2</sup> of a studio)
- In case of residency for less than a month, a studio fee will be calculated on a day.  
    ※ In order for facilitating international exchange programs, international artists are exempted from the studio&hostel fee.  
    (Please note that living and production expenses are responsible for an artist.)
- Participation in presentations of artists in residency.

## ○ Supporting artists of SASG following details

- Providing a studio and hostel
  - Artists for Domestic : A studio (16.529m<sup>2</sup>)
  - Artists for International : A studio (16.52m<sup>2</sup>-23.14m<sup>2</sup>) and hostel
- Participation in programs of Seoul Art Space\_Geumcehon  
(Workshop, Presentation, Open Studio, Exhibition, etc.)
- Supporting a specific sum of costs for progress such as making PR materials, just in case of artists are willing to make a presentation in SASG. (A maximum amount couldn't be over ₩500,000 (KRW) and SASG would directly make a payment.)

## ○ Application

- Announcement : 2010.3.10~2010.3.29
- Application period : 2010.3.15~2010.3.29
- Application method
  - Only online application will be accepted through the website of SASG.  
(It is unavailable to apply via mail and in-person)

- Application materials
  - : Please attach application materials. (tip : Please upload as a zip file.) Ex) your name. zip
  - Application form (Online application form at the website of SASG)
  - A copy of an artist's identification card(A copy of an artist's passport)
  - Project proposal (Attache a file with a free form)
  - Artist statement (Attache a file with a free form)
  - 8-10 Images of current works and a document of captions and short descriptions of each work. Total size of files should not exceed 10 MB.

- ※ Video files of MOV, AVI, or MPG formats should be shorter than five minutes. (This is required only for a media artist. If there is a problem up-loading a file, contact us at [nyoon@sfac.or.kr](mailto:nyoon@sfac.or.kr).)
- Other supporting documents (Accepted artists will be asked to submit certificates of their awards.)

- **Notification** : A list of selected artists will be posted at the website of Seoul Art Space\_Geumcheon(<http://geumcheon.seoulartspace.or.kr/eng/index.asp>)

## 2. Selection Process and Criteria

- **Selection process**
  - First round: Screening incomplete applications, ineligibility, etc.
  - Second round: Screening by the experts with application materials
  - Notification of acceptance
- **Screening criteria**
  - Locality and Internationality (10)
  - Excellence of a proposed project(50)
  - Possibility of the realization of a proposed project(30)
  - Availability of collaborative works(10)
